#### 1. Call to Order

The meeting was called to order at 6:04 p.m. by POC Co-Chair Langston Buddenhagen. POC members and staff introduced themselves.

#### 2. Open Forum

There was one public speaker: Courtney Johnson, Girls Incorporated of Alameda County.

3. Approval of Prior Meeting Minutes from October 7<sup>th</sup>, 2020

Bill Riley moved to accept the prior meeting minutes as submitted. Jorge Velasco seconded the motion. A roll call of the vote followed, and all members voted to approve the motion.

4. Approval of Transfer of Program Grant in Support of Comprehensive Afterschool Programming at Burckhalter Elementary School from Ujimaa Foundation to Girls Incorporated of Alameda County for the Current FY2020-2021 School Year and With the Option to Renew for the Upcoming FY2021-2022 School Year

OFCY Director Sandra Taylor introduced the request for a transfer of program grant from the Ujimaa Foundation to Girls Incorporated of Alameda County to provide afterschool services at Burckhalter Elementary School. Director Taylor referred to a letter from the CEO of Girls Inc., included in the POC meeting materials. Courtney Johnson spoke on behalf of Girls Inc., and the importance of maintaining the afterschool program at Burckhalter elementary. Tasion Kwamilele called for a motion to approve the transfer request. Kimberley Aceves made a motion to approve, and was seconded by Bill Riley. All members voted to approve the motion. Transfer request will go to City Council in January 2021.

Tasion Kwamilele introduced the item. Anakarita Allen reported on the presentation by SPR at POC Evaluation Subcommittee meeting on October 28, 2020. Jorge Velasco thanked SPR for putting together the report. Mika Clark, Heather Lewis-Charp, and Rachel Estrella from SPR then presented on the FY2019-2020 Final Evaluation Report of Oakland Fund for Children and Youth programs. Tasion Kwamilele called for a motion to adopt the OFCY Independent FY2019-2020 Evaluation Report. Jorge Velasco motioned to adopt, and Anakarita Allen seconded. All members approved the adopting of the report, with Peter Lê noting a spelling error in the report.

#### 6. Update on Strategic Investment Planning for 2022-2025

Director Taylor provided an update on the expected procedure and schedule for the 2022-25 Strategic Investment Planning cycle. Staff will focus on the strategic plan over the next few weeks and present at the next POC meeting particularly concerning the implementation of a racial equity lens for the 2022-25 plan. OFCY will be asking for community input on the plan in Winter 2021, and expects to present a draft plan to City Council by Summer 2021.

#### 7. Administrative Matters

The next POC meeting is scheduled for December 2nd. Kimberley Aceves expressed gratitude to Oakland's youth for helping secure the passage of Oakland Measure QQ, which lowers the voting age to 16 for Oakland Unified School District Board of Education elections.

POC Co-Chair Tasion Kwamilele adjourned the meeting at 7:10 p.m.



- 1/4 of Oakland's Latinx & Asian/Pacific Islander youth



#### Program Performance Score Card

These select performance measures were identified by program staff, OFCY and the evaluation team as indicative of programs' quality and success in working towards the strategic objectives for the Career Awareness and Employment Support strategy.

Because of the shelter-in-place order enacted on March 17, 2020, this report considers attendance from 7/1/2019 through 3/30/2020. Therefore, programs did not have the full year to meet their annual enrollment targets. For the "Total Hours of Service" measure, programs were assessed on their progress toward their projections for units of service through through the end of the third quarter (March 30, 2010).


