**2. Open Forum**

**5. Request for Proposal – Submissions Update**

OFCY staff gave a brief update on the RFP for 2019-2022; a total of 259 proposals were submitted by the January 25 deadline across seven funding strategies. Fifty external readers were acquired to review and score the proposals on their scope feasibility and appeal.

**Action Requested**

The POC is requested to approve the recommendation for 12 program grants totaling \$1,525,610 for programs operating in summer 2019 for Year 1 of the OFCY 2019-2022 grant cycle, as forwarded by the Ad-Hoc Review Subcommittee. Programs applied for funding through the OFCY 2019-2022 RFP through the **Summer Programs** and the **Career Awareness and Employment Support – Summer Youth Employment** funding strategies. Earlier review and approval of these programs is provided due to the need for programs to begin in June 2019. The Oakland Unified School District school year ends on May 30, 2019.

**POC Ad-Hoc Review Subcommittee Action and Summary of Grants Recommended**

The POC Ad-Hoc Review Subcommittee convened on February 25<sup>th</sup> to consider the recommendation of grants for summer programming in the 2019-2022 grant cycle. The staff reviewed the list of 22 applicants in response to the RFP through the Summer Programs strategy, and the seven (7) applicants that were submitted through the Career Awareness and Employment Support – Summer Youth Employment funding strategy. Nineteen (19) proposals in Summer Programs funding strategy and all seven (7) proposals in the Career Awareness and Employment Support – Summer Youth Employment funding strategy were forwarded for review.

The subcommittee reviewed summaries of the qualified applications ranked by the average reviewer score and presented by funding strategy. The additional preference points awarded to applicants by the City of Oakland's Contracts and Compliance Division were also presented to the Committee. As described in the Request for Proposal, funding determinations are made with consideration to location of services, services to priority populations, strategic alignment, past performance, and

reasonableness and feasibility of budget and activities. Funding recommendations support programming aligned with the vision, mission, values and strategic objectives as detailed in the 2019-2022 OFCY Strategic Investment Plan.

In consideration of the equitable distribution of funds, the subcommittee reviewed data regarding proposed client demographics, location of services, projected client location by City Council District, as well as costs for services proposed, breadth and scope of services including numbers served and hours of service, and past performance of programs currently funded by OFCY.

### ***Summer Programs Strategy***

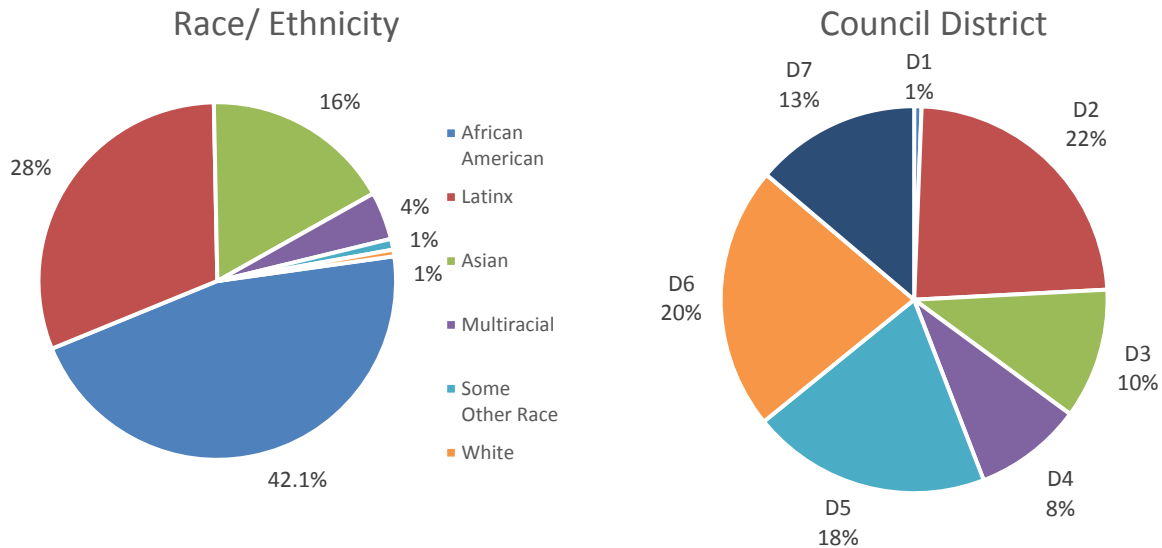
OFCY supports high quality summer programming by funding school- and community-based programs with an asset-based youth development approach to promote learning and peer and social connections. Programs that complement and enhance the enrichment provided at Oakland Unified School District summer school programs are supported, as well as community-based summer programs that provide opportunities for learning and provide youth with new experiences in areas such as the arts, STEM/STEAM, and youth and community development. Programming will provide opportunities during the summer months for enrichment, exploration, and new experiences that build confidence, self-esteem, and other important life skills in safe and supportive environments.

The OFCY 2019-2022 RFP identified as priority populations children and youth ages 5-14, as well as programs that support low-income African American, Latinx, Asian/ Pacific Islander, and Native American children and youth, and a priority for programming located in East Oakland, Fruitvale, and West Oakland.

OFCY reviewed 19 proposals requesting \$1,964,583 in funding. The subcommittee recommends funding to support nine (9) summer programs that are projecting to reach 2,789 children and youth. Total funding recommended for the strategy is \$1,175,610.

For the purpose of considering equity in the distribution of funding, race/ethnicity and the residence (by District) of the children to be served is considered in the review process. Based on the projections by programs recommended for funding, 42% of summer program participants will be African American, and 43% of participants will reside in Council Districts 3, 6 and 7. 91% of participants will be between 6 and 15 years of age. Programming recommended for funding will provide a range of both school-based and community-based programming options for children and families.

### ***Career Awareness and Employment Support – Summer Youth Employment (sub-strategy)***

OFCY's Career Awareness and Employment Support strategy is intended to support programs that build career awareness and provide employment support for older youth ages 14-21. Through career exploration, work readiness training, and employment, supported programs will provide youth with on-the-job experience, skill-building supports, and exposure to career options and pathways. The strategy supports year-round programs for students in school and for opportunity youth not connected to school or employment and supports summer programs that are coordinated with broader city efforts to boost youth employment experiences during the summer school break.

## **POC Meeting March 6, 2019: Summer Funding Recommendations**

The OFCY 2019-2022 RFP delineated three models of programming through the strategy areas, including Summer Youth Employment. In this substrategy, OFCY is partnering with the Oakland Workforce Development Board (OWDB) Summer Youth Employment Program/ Mayor's Summer Jobs to increase the number of summer youth employment opportunities. The strategy specified that awarded programs will align with the Oakland Summer Youth Employment program model, including the goal of providing youth ages 16 through 21 years of age with 100 hours of employment, compensation at the City of Oakland minimum wage, job readiness training, case management support for both youth and employer partners, and financial literacy training and access.

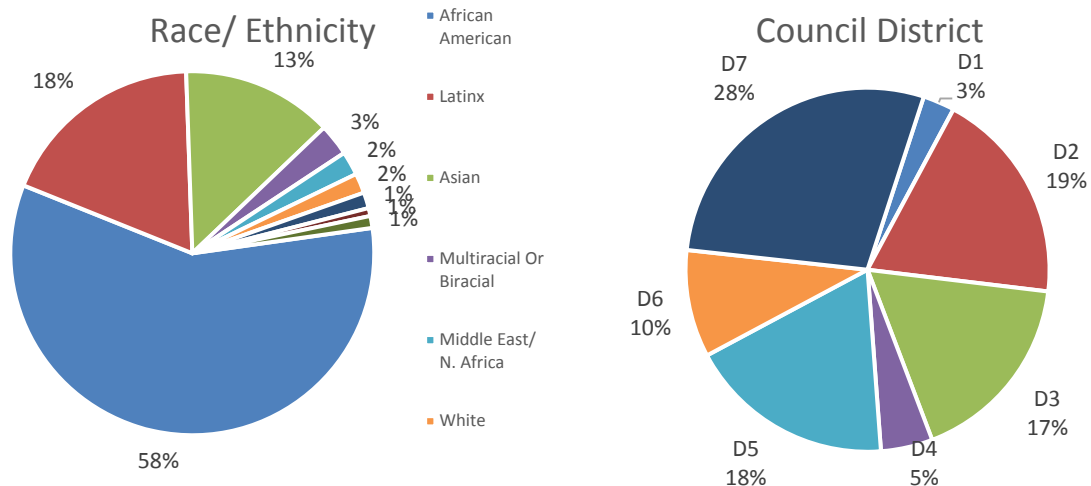
OFCY reviewed seven (7) proposals requesting \$1,345,835 in funding through this substrategy area. Six of the proposals indicated that they additionally would like to be considered for funding by the OWDB through this jointly-supported RFP strategy area, and these proposals have been provided to the OWDB for their funding consideration in addition and outside of the OFCY recommendation process. Based on the unique structure of this pilot with the OWDB, applicants submitted proposals that proposed services and funding levels at a higher level than if they were only applying for just OFCY funding support.

The subcommittee recommends funding to support three (3) programs for the Summer Youth Employment substrategy, with funding totaling \$350,000. Based on estimated costs per youth, OFCY expects the funds to support approximately 125 youth in summer employment, participating for 100 hours of work experience and receiving compensation at the Oakland hourly minimum wage level.

In order to examine racial and economic equity in the funding review process, the subcommittee reviewed data regarding proposed client demographics, location of services, projected client home location by City Council District, costs for services proposed, and breadth and scope of services including numbers served and hours of service. The recommendation is intended to support programming that serves Oakland youth citywide through Youth Employment Partnership, programming focused on serving youth in West Oakland, Chinatown and Fruitvale through Lao Community Development Corporation, and programming focused on youth residing in Council District 7 through Youth UpRising.

Based on the projections by programs recommended for funding, 58% of summer program participants will be African American, and 55% of participants will reside in Council Districts 3, 6 and 7. 100% of participants will be between 16 and 21 years of age.

Aim High prepares low-income youth of color for academic success through a free, multi-year summer learning and enrichment program. In summer 2019, we will add a fourth campus in Oakland, growing our enrollment to 440 students. These campuses will serve students ages 11-14 in grades six through nine; students can return for up to four summers. Our middle school program results in greater numbers of low-income Oakland students graduating from high school with the skills, knowledge and experience to matriculate to and succeed in college.

Since 1995 Oakland Fine Art Summer School (OFASS) has been a path towards summer fun and education for 220, K to 5th grade Oakland youth, currently attending OUSD schools. OFASS is a full day, four-week intensive summer program concentrating on Drama, Dance, Music and Visual Arts. This program is located at an OUSD school site. This partnership between OUSD and OPRYD allows youth not normally exposed to art throughout the city to have an opportunity to participate in a full day of art programs, to stimulate areas in the brains function, that ordinarily may not have this sensory stimulation.
