12.3.2025 – Meeting Minutes

- Timestamp 6:17 PM – AJ calls the meeting to order. Eight members of the committee are present, making quorum. Attendance is as follows:

- Timestamp 6:19 PM – AJ introduces the agenda for review and approval. JA motions to approve the agenda, SM seconds the motion. The agenda is approved with no abstentions or objections.
- Timestamp 6:21 PM – AJ introduces the minutes from the previous meeting for review and approval. JA motions to approve, AT seconds the motion. JM abstains, and the motion passes with seven ayes.
- Timestamp 6:22 PM – AJ introduces public forum. Four youth are present from Youth Alive’s Teens on Target program. More information can be found on the speaker cards submitted.
- Timestamp 6:25 PM – NS arrives.
- Timestamp 6:29 PM – AJ introduces the City Auditors team to present on the recent audit of OFCY’s finances. The slides are attached to the end of these minutes.
- Timestamp 6:47 PM – LH arrives.
- Timestamp 7:06 PM – AJ introduces Bay Area Outreach & Recreation Program for their Grantee Spotlight. Slides are attached to the end of these minutes.
- Timestamp 7:19 – MJ arrives
- Timestamp 7:35 PM – AJ introduces the 8th item on the agenda, administrative updates. RML provides an update about the RFP process, reader recruitment, the upcoming RFQ, and the fiscal and budget (FAB) team’s review of past expenditures. LH suggests a debriefing activity with youth readers.
- Timestamp 7:44 PM – LH notes the disparity study that was recently released. RLL states that OFCY and the City of Oakland must comply with AI 580 to address racial disparities within the community, while navigating the requirements under Prop 209.
- Timestamp 7:49 PM – AJ introduces agenda item 8; RLL notes the FAB team presentation will occur in early 2026. RLL provides an update on contract status, noting that only 4 of OFCY’s 77 agencies have executed contracts. ME asks why this is a limited number of contract executions. RLL explains that, despite OFCY staff submitting their contracts to the portal, the contracts admin division is inundated with contracts, significant delays (minimum 90 days) are occurring.
- Timestamp 8:03 PM – ME poses the option to invite the Contracts Admin team to an upcoming POC meeting to discuss contracting delays and ways to reduce the impact on all agencies. AJ suggests the POC and OFCY staff create a “list of asks” to share with Contracts Admin to mitigate this challenge.

- Timestamp 8:22 PM – ME motions to invite a representative from the City Administrator’s Office and Contracts Admin to the POC to discuss ways to minimize contracting delays. JM seconds the motion. The motion passes without abstention or objection.
- Timestamp 8:23 PM – JM shares that this is her final meeting as D3 representative. OFCY staff and POC members thank her for her service to Oakland’s Youth.
- Timestamp 8:28 PM – AJ adjourns the meeting.
